## Location...

The tourist resort of Ingoldmells along with Skegness and Mablethorpe is located on the Lincolnshire coast famous for its tourist attractions including Fantasy Island, Butlins holiday resorts as well as a large number of other attractions.

The resort is located on the A52 trunk road. It is estimated to have an annual population in excess of 2.5 million tourists per year.

The area is currently undergoing significant investment, there are a number of schemes under investigation in the area.

The beach to be sold is unusual in that it includes land measured to the low tide level as per the Ordnance Survey plans attached with these details.

The beach has been lotted in a number of areas, details of which are included with this brochure.

## Description...

Plot A
Is a 14.4 hectare, 35.5 acre area of beach located in front of Butlins resort measured up to an irregular line before the promenade. It comprises sand dunes and beach and has 735 m of sea frontage as per the plan attached with these details.

## Plot B

This is a plot of land extending to 1.8 hectares, 4.5 acres, including some promenade with a sea frontage of 100 m extending to sand dunes and beach.

Plot C
This is a 8.5 hectares, 21 acres, plot extending to provide 420 m of sea frontage including promenade and a strip of sea bank as per the attached plan shown on the Ordnance Survey.

Plots D, E, F and G
These are 100 m wide plots of $4.7-6$ acres each at $£ 50,000$ per plot up to and including the promenade down to the low mean water level and comprise mainly beach.

Plot I
This is an area of land to the east of the promenade comprising sea bank with an average width of 12.5 m , 40 ft being approximately 330 m long and extending to 0.4 hectares, 1 acre.
