Location...

The rapidly expanding town and village of Kirton is located outside the large town of Boston approximately 115 miles to the north of London, 35 miles to the south-east of Lincoln, 50 miles to the east of Nottingham and 40 miles to the west of King's Lynn.

Kirton Distribution Park is adjoining the A16 trunk road connecting Kirton to Spalding, Peterborough and the A1 trunk road. The A17 trunk road and A52 trunk road are accessed via the A16 at the Sutterton Roundabout.

A combined population of Kirton and Boston exceeds 83,000 residents and has a strong retail, sporting and leisure offering, a large hospital, active port, twice weekly market and a rich history going back to the 10th Century with associations with the Hanseatic League.

The site is located at the southern end of Kirton Distribution Park with access off the A16.

Other occupiers include Duckworth Landrover, Domino's Pizza, Sportsbikeshop, Murlec, DHOOT UK Parkinson Tech, Autoglass and a wealth of other occupiers.

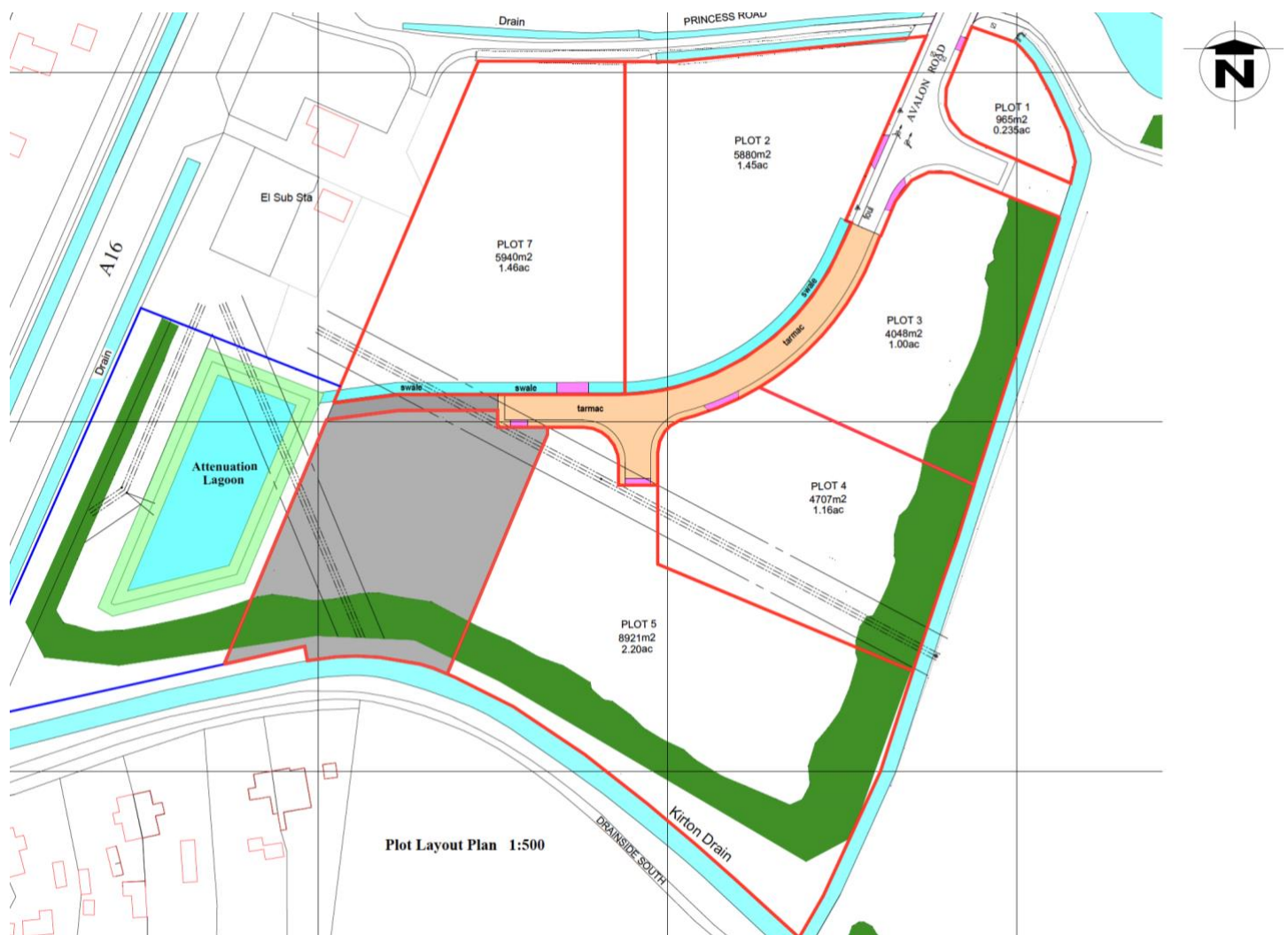

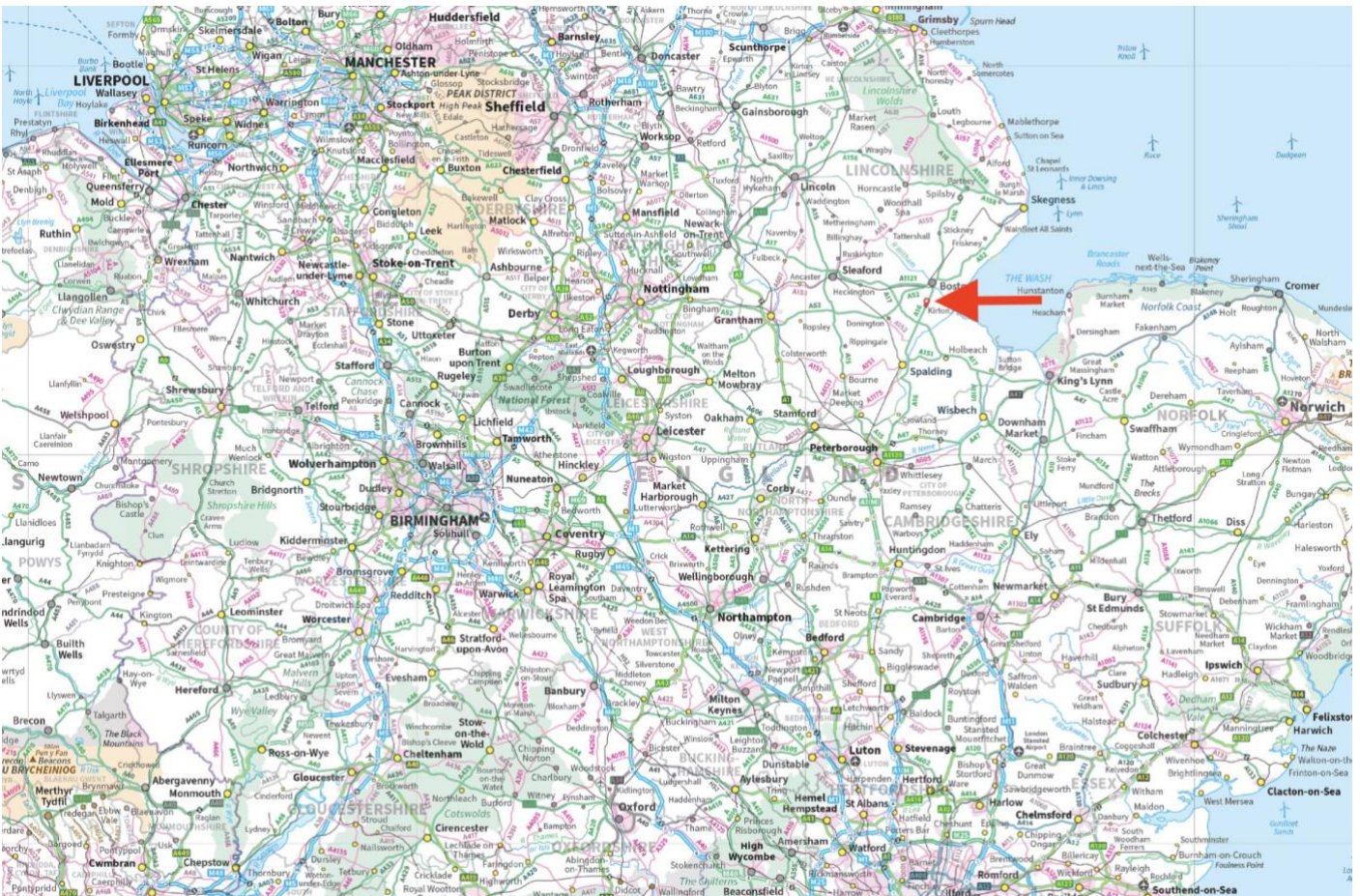
